

## **1. ADMISSION**

Admission to the event is FREE.

Audi Hungaria Győr is holding an open day to celebrate its 30th anniversary this year on 8 July 2023. The programmes can be attended from 10 am to 6 pm. By entering the event area, the “Visitors” accept these House Rules and acknowledge that Audi Hungaria and its employees, agents and subcontractors (hereinafter referred to as “Organizers”) shall comply with them.

## **2. USE OF EQUIPMENT AT THE EVENT**

Visitors to Audi Hungaria will have the opportunity to go behind the scenes of one of the world’s largest engine factories and most advanced car factories. The Open Day aims to showcase the exclusive models and developments of the factory. Also, it offers fun activities and distraction for the whole family. The use of certain equipment during the programmes is at the responsibility of each individual and must be in accordance with the specific rules of each installation, taking into account the advice and suggestions of the Organizer on site, and Visitors must comply with the safety conditions posted on the spot. Access at the event area is restricted to designated locations.

## **3. FORBIDDEN OBJECTS**

It is FORBIDDEN to bring into the factory premises any alcoholic drinks, glassware, objects that can be used for hitting, stabbing or cutting, drugs, pyrotechnic products, objects or items containing explosive, toxic or flammable substances, as well as firearms, ammunition, gas sprays or other objects or items that are particularly dangerous to public safety. Furthermore, it is also FORBIDDEN to bring in press products, objects, publications, illustrations and similar objects and items that are capable of inciting hatred against Hungary or any other country, people, nationality, religion or race, or that are offensive to general human values, public morals, public decency, or human rights. These items may be confiscated at the entrance and on the entire territory of the event. Visitors may not claim ownership or any contractual right against the Organizer for any items confiscated at the event site. A Visitor who resists confiscation may be removed from the event area. It is FORBIDDEN to bring live animals and other products subject to animal health restrictions, as well as any materials and parts needed for the production of cars and engines into the area of the factory. Visitors may not enter the Event area with restricted items. Flying a drone in the Event area is strictly FORBIDDEN and illegal, and will result in legal action. In the event that a Visitor attempts to fly a drone on or outside the premises, s/he will be invited by the Organizer to stop the activity and will be held fully responsible for the payment of any fine that may be imposed for the activity, which will be immediately recorded on the premises. By entering the event area, Visitors agree that Audi Hungaria and its contracted partners will carry out exclusive marketing activity for the duration of the event, throughout the entire event area. Any Visitor who interferes with this marketing

activity, engages in activities for competing advertisers, or causes damage to advertising materials may be removed from the Event immediately and will be held fully responsible for damages, and any advertising materials found on their person may be confiscated by the Organizers without compensation.

#### **4. FORBIDDEN ACTIVITIES**

NO alcoholic beverages are sold in catering facilities on Audi Hungaria's premises and it is FORBIDDEN to drink alcoholic drinks on the factory premises. Smoking is only allowed in designated areas. No drunk or intoxicated persons are allowed to enter the factory premises. The use of drugs on the factory premises is FORBIDDEN and will result in prosecution. A person who is found, beyond reasonable doubt, to have abused drugs may be removed from the Event area. Any damage to the environment and nature within the factory premises is strictly FORBIDDEN and will result in liability for damages and legal action. It is forbidden to enter the Event area by vehicle without the Organizer's permission. Persons holding a vehicle pass are also obliged to fully comply with the Highway Code and to leave the Event area after the time limit set by the Organizer.

Visitors must refrain from any conduct that are capable of causing injury to life, limb or personal rights of others or damage to their property. Visitors must not engage in any behaviour that is offensive, obscene or blatantly anti-communal, in particular with regard to political and religious or ethnic references and rallies, and it is strictly FORBIDDEN to bring such banners into the Event area.

For the safety of Visitors, access to restricted areas inside and outside the factory, marked with warning tape and signs, is FORBIDDEN. Any Visitor who violates this provision will be removed from the Event area by the Organizers in case of disorderly conduct. Visitors, irrespective of the owner, must refrain from any conduct that may cause damage to the equipment and items used for the Event. Visitors shall be fully liable for any damage caused by them.

#### **5. MEDIA AND AUDIOVISUAL DEVICES**

Visitors are allowed to take photographs and film in the designated and accessible areas, provided that in the case of any recordings made by a Visitor, the Visitor is responsible for compliance with the legislation in force at the time of making the recordings. Visitors also acknowledge that the Organizers and their authorized Contracted Partners, Contributors, press staff and other Visitors and other third parties may make audio and video recordings of the Event. For further information, please consult the Privacy Policy.

Accordingly, by entering the Event, Visitors expressly consent to the recording and publication of their face, appearance and manifestations, provided that they may be named only with their express consent. The Organizers and the authorized Contractual Partners of the Organizer shall

be entitled to exploit, use (in particular for the promotion of the Event), reproduce, disclose, adapt, publish, transmit and distribute such information in relation to the Visitor without any limitation and without any obligation to provide any consideration to the Visitor.

Visitors also specifically acknowledge that the Event or the Programmes may be recorded by the Organizers, or may be reproduced and distributed, broadcast or otherwise communicated to the public on an image carrier, including where the Event or the programmes are made available to the public by wire or any other means that allows members of the public to choose individually the place and time of access. Visitors shall have no right to make any claim or demand against the Organizers in connection with the above. Visitors may not sell or use the images and sound recordings made by them for any consideration, nor use them for commercial purposes without consideration, nor name the Visitors depicted in them without their consent, nor infringe their privacy rights. The Organizers expressly exclude any liability in the event of any breach of the above by other Visitors.

## **6. EXCLUSION OF LIABILITY**

The Organizers shall not be liable for any damage to persons or property during the Event. The Organizers shall not be liable for any abandoned/damaged valuables within the area of the Event.

## **7. ASSISTANCE, COOPERATION**

Audi Hungaria employees with the appropriate qualifications and authorizations will ensure that the rules of conduct and safety are enforced in the Event area. By participating in the Event, Visitors expressly undertake to cooperate with these contributors to the fullest extent permitted by law and to follow their instructions in case of emergency. Visitors are obliged to hand in lost and found property to the information desk. Visitors can collect their lost object with proof of ownership.

The Event will also be held in case of bad weather. The Organizers reserve the right to change the programme.
