What does the Return of Special Resources mean?

The Return of Special Resources describes a process which withdraws no longer required equipment of the Volkswagen Group and its suppliers from the value-chain.

It aims at recycling, reusing or feeding these special resources to a scrapping company.

The Components-Toolshop (HFB-T) coordinates this task worldwide for all suppliers of the Volkswagen Group.

Benefits for Supplier

The suppliers can benefit from the following advantages:

- Prompt, professional and environmentally compatible return of special resources
- Release of store room for new projects
- Cost saving by reducing store room
- Protection of internal know-how
- Defined contact persons
- Reduction of maintenance costs

Introduction of Process

The evaluation process starts as soon as the scrapping application form is mailed to the Component-Toolshop department (HFB-T) (pruefung-werkzeugbedarf@vwgroupsupply.com) The scrapping application form can be obtained by the contact persons listed in this flyer. An evaluation of special tools without the scrapping application is not possible. Scrapping applications can be made anytime. However, a supply security to at least 15 years after end of production has to be ensured and further contract agreements with the Volkswagen group have to be fulfilled.

Process Information

- The scrapping application has to be filled out completely. In case of questions you will be supported by the contact persons
- Photos of the tools are needed to accelerate the processing procedure
- A scrapping of the special resources is only permitted with the authorization of the Volkswagen Group
- The scrapping companies are always instructed by the Volkswagen group
- Scrapping approvals and rejections have to be made in written form
